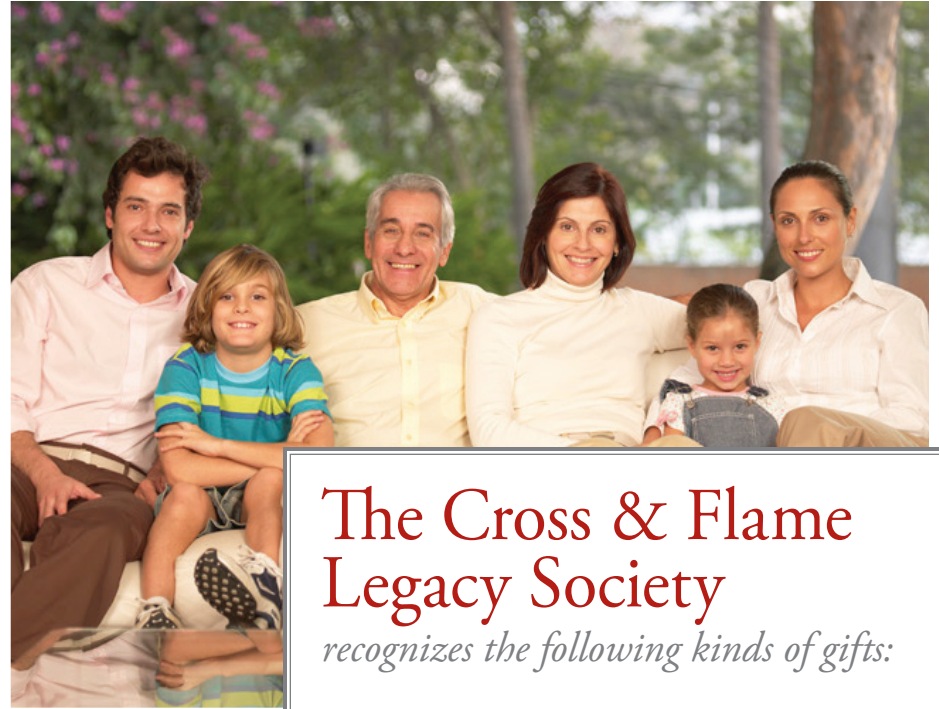

The Cross & Flame Legacy Society

recognizes the following kinds of gifts:

Current gifts that establish permanent endowment

The gift of a home or farm with a retained life estate

Bequests made through a will or revocable living trust

Gifts from which the individual receives a life income in return (i.e. gift annuities, unitrusts, annuity trusts, etc.)

Beneficiary designation on IRAs, CDs, commercial annuities, savings accounts, savings bonds, etc.

What is it?

The Oklahoma United Methodist Foundation's **The Cross & Flame Legacy Society** encourages individuals to remember United Methodist causes with estate or other planned gifts arranged during their lifetimes.

To be a part of **The Cross & Flame Legacy Society**, you (or your attorney or financial advisor) must notify the Foundation you have included a United Methodist cause in your estate plans. As a member of **The Cross & Flame Legacy Society**, you will have an ongoing relationship with the Foundation and will be advised of special events and ministry projects.

While public recognition often inspires generosity in others, confidentiality will be strictly respected.
